How We Track Homelessness

Homelessness affects more people over a year than a single night can show. To guide effective solutions, Pasadena uses two complementary approaches to measure homelessness.



Annual Count

The number of people who experienced homelessness over the course of a **calendar year**



Point In Time Count

Required by HUD; the number of unhoused people on a **single night**



2024 Annual Count

1,047 people experienced homelessness during the 2024 calendar year—a 5% decrease from 2023.



Continued Progress in Housing Placements

In 2024, 327 people experiencing homelessness in Pasadena secured permanent housing, bringing the three-year total to more than 1,000 people.

Permanent housing placements matter, but reducing homelessness also depends on addressing system inflows.

Inflows

(people entering the system)

- First-time homelessness *
- ↻ Returns to homelessness *
- 🌹 Moved to Pasadena while unhoused
- 🏥 Discharged from institutions without housing

Outflows

(people exiting the system)

- 🏠 Permanently housed
- 👥 Temporarily housed
- 🗺️ Moved out of Pasadena
- 🏥 Admitted to institutions
- ⚰️ Passed away



Rising Inflows to Homelessness

Of the 1,047 people who experienced homelessness in 2024, 270 became unhoused in the past year, up from 215 in 2023. This includes people experiencing homelessness for the first time and those returning after a prior episode.



Men Outnumber Women Across All Age Groups

Across every age group, men make up a larger share of Pasadena's homeless population—especially among adults ages 35 to 64.





Racial Disparities in Homelessness

This pattern has remained consistent in recent years and is seen in LA County and nationwide, reflecting widespread disproportionality in homelessness.



High Rates of Disabling Conditions

In 2025, 79% of people in Pasadena's annual count and 72% in the Point In Time count reported one or more long-term disabling conditions.

About the Count



February 19, 2025

Conducted annually over a 24-hour period.



Point In Time

One-night count of unhoused people in Pasadena.



Eaton Fire

Delayed by the Eaton Fire, the count took place six weeks after the fire started.

Who Is Counted in the Point In Time Count



Sheltered Count

People staying in transitional housing or emergency shelters including motels or the Bad Weather Shelter



Unsheltered Count

People living outdoors, in vehicles, abandoned buildings, or a garage or shed

Does not include: people doubled up, couch surfing, or at-risk of homelessness



2025 Point In Time Count Results

Pasadena counted 581 people experiencing homelessness on the night of the 2025 Point In Time count—a 4% increase from the one-day count in 2024.

Notable Shifts in 2025 Point In Time Count

The Point In Time count is a snapshot of one night and may reflect short-term fluctuations rather than year-round trends.



Displacement from Fires

The sheltered count included 12 people who reported they were directly impacted by the Eaton Fire.



Rise in Unsheltered Homelessness

342 people were unsheltered in 2025, a 7% increase from 321 in 2024, an increase of 21 people.



Regional Mobility


The number of unsheltered residents previously housed in the surrounding San Gabriel Valley increased by 21 people in 2025.

** The Homeless Count was not conducted in 2021 due to the pandemic.




Sheltered Count

239 people were in emergency shelters or transitional housing during the 2025 count, nearly unchanged from 235 in 2024.

Use of **emergency shelters*** rose by **9%** between 2024 and 2025.




Unsheltered Count

342 people were unsheltered during the 2025 count, a 7% increase over 2024.

More than half of unsheltered residents (54%) were sleeping on the street or sidewalk, representing the most visible form of homelessness.


Top Unsheltered Sleeping Locations 2024 vs. 2025

84% of people were last housed in LA County.

Half of unsheltered people who were surveyed lived in Pasadena for an average of 19 years before losing their housing.



Single Adults Make Up a Growing Share of the Unhoused Population

In 2025, 485 individuals experiencing homelessness (83%) were single adults without children, a 7% increase over 455 single adults in 2024.



Chronic Homelessness

Compared to families, single adults are far more likely to be chronically homeless (58% vs. 21%).

Long-Term Disability

Similarly, single adults are more likely to have a long-term disability than people in families (72% vs. 23%).



Families with Children

In 2025, 96 people in 30 households were in families with children, similar to 2024 (101 people in 32 households).

Demographics Among Families with Children Are Shifting

Compared to 2024, families were less likely to be Hispanic/Latina/e/o and more likely to be Black or African American.

Downward Trend in Veteran Homelessness

While veteran homelessness rose in 2023, the count has declined for two consecutive years.

Key Takeaways

01

5% Decrease in Annual Count

In 2024, 1,047 people experienced homelessness, offering a year-round view of trends prior to the Eaton Fire.

02

327 People were Permanently Housed in 2024

Exits to permanent housing remained steady after a 2023 peak.

03

Rise in Unsheltered Homelessness during the Point In Time Count

Unsheltered homelessness grew by 7% (321 in 2024 to 342 in 2025).

04

Regional Factors Influence Pasadena's Homelessness

The share of unsheltered residents last housed in other cities in the San Gabriel Valley increased from 9% in 2024 to 14% in 2025.



LOOKING FORWARD

Shifting Landscape

Threats to federal funding and widespread instability following the Eaton Fire present new challenges in 2025, while increased funding from Measure A is anticipated.

Deepen Regional Collaboration

Improved coordination with neighboring cities is needed to strengthen the regional response to homelessness.

Expand Permanent Housing

New permanent housing projects are needed to sustain exits from homelessness and meet long-term goals.

Build on Existing Shelter Resources

Expanded year-round shelter capacity is needed to meet growing demand and achieve system goals.
